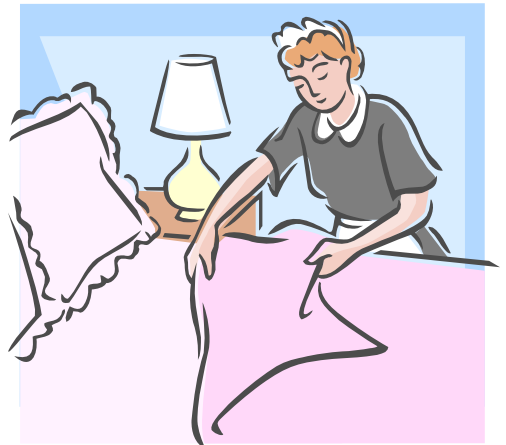
Master Bathrooms Debut to Rave Reviews

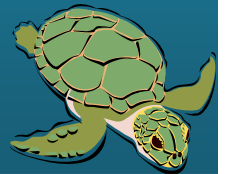
