EXHIBIT "A"

To amend the Declaration of Condominium of Surf Club of Marco to amend Article IV, Section 1 as set forth below:

ARTICLE IV.

1. **Timesharing Estate Ownership.** Units in the Condominium are being created and sold as timeshare estates as defined in Article 1 of the Declaration and as defined in the Condominium Act. Each unit is divided into fifty-two (52) timeshare estates as identified and defined in Paragraph 2 of this Article. The owner(s) of each timeshare estate shall own the timeshare estate conveyed to him, subject to the terms and conditions contained in the Declaration of Condominium and the Exhibits attached hereto, until ~~December 31, 2020~~ December 31, 2040 at which date the timeshare estate and the condominium form of ownership shall terminate unless the Condominium is sooner terminated in accordance with the provisions of the Declaration or unless the timeshare regime and condominium is extended by agreement of the unit owners. Upon the termination of the Condominium, the owner(s) of a timeshare estate shall become tenants in common in the fee ownership of the unit with all other owners of all other timeshare estates in that unit shall be entitled to all rights afforded to joint owners of property.
