# ARTICLE IV. DIRECTORS

Section 1. Number, Term Qualifications: The affairs of the Association shall be governed by a Board of Directors composed of not less than three (3) nor more than seven (7) persons, as is determined from time to time by the members. All Directors, except those designated by Developer, shall be members of the All Officers of a Association. Corporate Unit Owner shall be deemed to be members of the Association so as to qualify as a Director herein. The term of each Director's service shall extend until the next annual meeting of the members and thereafter until his successor is duly elected and qualified, or until he is removed in the manner provided in Section 3, below.

# ARTICLE IV. DIRECTORS

Section 1. Number, Term Qualifications: The affairs of the Association shall be governed by a Board of Directors composed of not less than three (3) nor more than seven (7) persons, as is determined from time to time by the members. All Directors, except those designated Developer, shall be members of the All Officers of a Association. Corporate Unit Owner shall be deemed to be members of the Association so as to qualify as a Director herein. The term of each Director's service shall extend until the next annual meeting of the members and thereafter until his successor is duly elected and qualified, or until he is removed in the manner provided in Section 3, below. In 1988, the two candidates receiving the most votes will have two year terms and, the candidate receiving the third most votes will have a one year term. Every year after 1988 the successful candidates will have a two year term. A Director may not serve more than four consecutive years, and shall not be eligible for re-election until one term has elapsed. Nothing in this Section shall preclude the removal from office of any Director as provided in Section 3 below.
